- 2. Payment in full shall be made on or before the 10th of the month for all purchases made in the previous month. Purchaser agreesto pay a late charge of 1 ½% per month on all amounts not paid by the 15th.
- 3. Applicant agrees that all costs of the collection, including attorney's fees, may be collected, and waives right to a jury trial. Thisagreement shall be governed by and in accordance with the laws of the State of North Dakota and any action brought hereundershall be brought in Cass County, North Dakota.
- 4. Except for the express manufacturer warranty, if any, which accompanies the product purchased, Wallwork Truck Center gives nowarranties, either express or implied, including but not limited to warranties of merchantability or of fitness for a particular purpose.
- 5. This agreement shall be continuing unless mutually terminated by both parties in writing.
- 6. I further certify that I am an officer of Customer, knowledgeable of the financial conditions of Customer, and that I am empowered and authorized to enter into the aforesaid Agreement on Customer's behalf.
 - 7. Grant of Security Interest. The undersigned on behalf of the customer hereby grants Wallwork Truck Center a security interest inany and all equipment and motor vehicles owned by the customer for all obligations outstanding to Wallwork Truck Center. Thecustomer understands that the Security Interest extends to all of the vehicles and equipment owned by the customer includingvehicles and equipment in which parts or service work was incorporated into the vehicle or equipment. The customer furtherunderstands that the security interest also extends to all vehicles that the customer has financed with Wallwork FinancialCorporation. This security interest is in addition to any other rights Wallwork Truck Center may have including North DakotaMechanic's lien law.
